Subject: Appointments to Cabinet, committees and other bodies

- Report of: Interim Monitoring Officer
- Portfolio: All

Report Summary

This report sets out the membership of Cabinet and the proposed appointments to the committees of NTCA and other bodies, and the process to appoint Mayor's Ambassadors for Business and the Community and Voluntary Sector (CVS) respectively.

Recommendations

Cabinet is recommended to:

- 1. note the Cabinet membership set out at Appendix 1(a) and that the Mayor is to appoint a Cabinet member as Deputy Mayor;
- 2. agree the allocation of Cabinet portfolios set out at Appendix 1(b) and the schedule of meetings for the municipal year 2019/20 set out at Appendix 1(c);
- 3. agree the approach to the appointment of the Mayor's Ambassador for Business and the Mayor's Ambassador for CVS set out in section 2 below and authorise the Interim Head of Paid Service, in consultation with the Mayor, to finalise the details of and then implement the application processes;
- 4. agree the membership of the Overview and Scrutiny Committee, Audit and Standards Committee and the Housing and Land Board as set out in Appendix 3;
- 5. agree the appointment of members and substitute members to the Joint Transport Committee and the Tyne and Wear Subcommittee as set out in paras 6.1 and 6.2;
- 6. agree that Cllr Forbes shall be NTCA's representative on the board of Transport for the North (TfN) and that Cllr Jackson shall be the substitute member; and

7. agree that Cllr Johnson shall be NTCA's representative on TfN's Overview and Scrutiny Committee and that Cllr Pickard shall be the substitute member.

1. Cabinet Members, portfolios and appointment of Deputy Mayor

- 1.1 The table at Appendix 1(a) sets out the members and substitute members which each constituent council and the North East Local Enterprise Partnership ("NELEP") have appointed to NTCA's Cabinet.
- 1.2 The Mayor of NTCA is the chair of Cabinet. The Mayor must appoint one of the members of Cabinet as his deputy who will be able to exercise his functions and decision-making powers in his absence.
- 1.3 The table at Appendix 1(b) sets out the proposed allocation of Cabinet portfolios to the Cabinet members for Cabinet to consider. A proposed schedule of meetings of Cabinet and other committees is attached as Appendix 1(c)

2. Mayor's Ambassadors for Business and the CVS

- 2.1 The Mayor may nominate one person to be the Mayor's Ambassador for Business. As set out in para 6 of Part 2.2 of the Constitution (see Appendix 2(a) to this report), Cabinet must approve the process for that appointment which must include the following elements:
- 2.1.1 a person can only be nominated by the Mayor for the role if he or she is resident, or operates a business, in the North of Tyne area, and he or she has been proposed by a recognised business organisation; and
- 2.1.2 the person has submitted an application in accordance with a procedure and timetable determined by the Cabinet.
- 2.2 It is therefore proposed that the business organisations listed in Appendix 2(b) be contacted as to whether they wish to propose a candidate who will then be required to submit an application form setting out their relevant experience and skills for the role. The applications will be considered by an ad hoc panel comprising the Mayor and a Cabinet member from each local authority. The Mayor shall then nominate one of the candidates as the proposed Mayoral Ambassador who will be appointed if Cabinet agrees.
- 2.3 As noted in Part 2.2 of the Constitution, other mayoral ambassadors may be appointed and it is proposed that a Mayor's Ambassador for the CVS is also appointed (with the potential scope to appoint ambassadors for other sectors in the future). The process for that appointment will be the same as that described above, with the eligibility criteria being:
- 2.3.1 a person can only be nominated by the Mayor for the role if he or she is resident, or works, in the North of Tyne area, and he or she has been proposed by one of the CVS organisations set out in Appendix 2(c); and

- 2.3.2 the person has submitted an application in accordance with a procedure and timetable determined by the Cabinet.
- 2.4 It is proposed that the Interim Head of Paid Service, in consultation with the Mayor, be authorised to finalise the details of the application process and then implement that process, with a report being brought to Cabinet in due course as to the decision to appoint the Mayor's Ambassador for Business and the Mayor's Ambassador for the CVS.

3. Overview and Scrutiny Committee (OSC)

3.1 The OSC comprises 3 members from each constituent authority. The composition of the OSC must reflect political balance across the authority as a whole. Taking account of recent local election results, the distribution of seats remains as follows:

Newcastle2 Labour; 1 Liberal DemocratNorth Tyneside3 LabourNorthumberland2 Conservative; 1 Labour

Substitute members must be appointed on the same basis. The proposed membership of the OSC is set out at Appendix 3(a)

3.2 The Chair of the OSC must be an appropriate person, ie an elected member from a group other than the Mayor's group. NTCA's Constitution envisages that Cabinet shall appoint the Chair of the OSC at its Annual Meeting, although Cabinet has previously delegated this decision to the OSC itself.

4. Audit and Standards Committee (ASC)

4.1 This Committee comprises 3 members from each constituent authority and one independent co-opted member who chairs the committee. The current independent chair is Doug Ross, who was appointed by Cabinet in February 2019. The membership of the ASC must also reflect political balance across the Authority, which results in the same allocation of seats as set out in paragraph 3.1. The proposed membership of the ASC is set out at Appendix 3(b).

5. Housing and Land Board (HLB)

- 5.1 The HLB is an advisory board. Part 2.4 of the Constitution provides that Cabinet shall appoint the members of the Board at its Annual Meeting. The proposed membership is set out at Appendix 3(c).
- 5.2 Following the election of the Mayor the appointment of the Inclusive Economy Board (which is another advisory board) will now be progressed and will be the subject of a report to Cabinet in the near future.

6 Joint Transport Committee (JTC)

6.1 NTCA must appoint 3 of its members to the JTC, one of whom shall be the Elected Mayor unless he agrees otherwise. NTCA must also appoint 3 substitute members. The following appointments are proposed:

6.2 NTCA must also 2 members and 2 substitute members to the Tyne and Wear Subcommittee of the JTC. The following appointments are proposed:

6.3 NTCA will also be required to appoint members to the Joint Overview and Scrutiny Committee and Joint Audit Committee which are linked to the JTC. These appointments will be dealt with in a future report to Cabinet.

7 Transport for the North

7.1 NTCA appoints one member (and one substitute member) to TfN's Board. It is proposed that these appointments will remain as follows:

Appendix 2(a) – extract from Part 2.2 of NTCA's Constitution

6. Mayor's Ambassador for Business

- 6.1 The Mayor may nominate one person to be the Mayor's Ambassador for Business and the Cabinet will appoint such a person to that role if a majority of voting members agree to the appointment, subject to paragraphs 6.2 and 6.3.
- 6.2 Any person who satisfies the following conditions is eligible to be nominated for appointment as the Mayor's Ambassador for Business:
- 6.2.1 the person is resident, or operates a business, in the area of one of the constituent councils; and
- 6.2.2 the person is proposed to be the Mayor's Ambassador for Business by a recognised business organisation.
- 6.3 A person may not be appointed as the Mayor's Ambassador for Business unless they submit an application (in accordance with any application procedure and timetable determined by the Cabinet) and they satisfy both conditions in paragraph 6.2 at the date of their appointment.
- 6.4 The Mayor's Ambassador for Business will hold his/her position for as long as the Mayor holds office or the Mayor, with the support of the majority of the voting members of Cabinet, terminates the Ambassador's appointment.
- 6.5 The Mayor's Ambassador for Business will attend Cabinet meetings as an observer but shall not be entitled to remain during those parts of a Cabinet meeting when the press and the public have been excluded.
- 6.6 The Mayor's Ambassador for Business will comply with NTCA's Code of Conduct for Members.
- 6.7 To assist and advise NTCA in fulfilling its responsibilities, further Mayoral Ambassadors representing other sectors such as the Community and Voluntary Sector may be appointed by a majority of the voting Cabinet Members.
