#### **Decision:**

- Subject to the outcome of a grant application of funding from the North of Tyne open innovation challenge activity, issue a grant offer letter up to the value of £1,291.571 for the Challenge North East Programme to the North East LEP and to enter into associated partnership agreements.
- 2. To issue a grant offer letter for revenue grant of £125,000 from the Local Growth Fund Programme balances to Gateshead City Council towards the North East Business Event Subvention Fund pilot project, subject to conditions.
- To issue a grant offer letter of an additional £500,000 grant from the Local Growth Fund Programme balances to the North East Inward Investment Grant (NEIIG scheme).
- 4. To enter into a grant funding agreement to provide a Getting Building Fund grant award of £1,250,000 to the Port of Blyth Authority for the Battleship Wharf project, Blyth Estuary.

- 5. To enter into a grant funding agreement to provide a Getting Building Fund grant (including a North East Investment Fund contribution) of £965,585 to Arbucc (Drum) Ltd for the Panther Court, Drum Industrial Estate project.
- 6. To novate and vary an existing funding agreement to provide additional Enterprise Zone programme funds of £985,270 to Advance Northumberland for the Ashwood Business Park project.
- 7. To enter into a grant funding agreement to provide a North East LEP Project Development Accelerator Fund grant award of £150,000 to Tyne Coast College to support the South Shields campus relocation project.
- 8. To issue a grant funding letter to provide a North East LEP Project Development Accelerator Fund grant award of £55,000 to the North East LEP Skills Team to develop the Collaboration of Digital Expertise (CODE) project.
- 9. To enter into a grant funding agreement to provide a North East LEP Project Development Accelerator Fund grant award of £70,000 to Newcastle City Council to support the Biosphere 2 project.
- 10. To issue a grant funding letter to provide a North East LEP Project Development Accelerator Fund grant award of £52,500 to North East LEP Business Growth Team to support the North East Life Science Manufacturing and Innovation Zone project.
- 11. To enter into a grant funding agreement to provide a North East LEP Project Development Accelerator Fund grant award of £70,000 to Transport North East to support the South of Tyne and Wear Wearside and Metro Loop project.
- 12. To enter into a grant funding agreement to provide a North East LEP Project Development Accelerator Fund grant award of £80,000 to North Tyneside Council to
