Title: Economic Inactivity Trailblazer Programme

Report Summary

In December 2024, the North East Combined Authority (North East CA) were identified as an Economic Inactivity Trailblazer, bringing together health, employment, and skills services to improve the support available to those who are inactive due to ill health and help them return to work. This included an award of £10m for delivery in 2025/26.

In January 2025, Cabinet delegated responsibility to the Chief Executive, in consultation with the Director of Finance and Investment, Monitoring Officer and relevant Cabinet Member to approve project applications and contracts brought forward through the approved Economic Inactivity Trailblazer Delivery Plan, in line with the North East Single Assurance Framework.

This report provides specific details of the Economic Inactivity programme including a summary of the investment activities, proposed commissioning approach, scope of activity and associated outputs and outcomes. All individual funding awards will be confirmed in line with the delegations set out in the Single Assurance Framework.

Recommendation

The Chief Executive is recommended, to approve the Economic Inactivity Trailblazer Delivery Plan, proposed approach and associated outputs and outcomes.

A. Context

1. Background

- 1.1 In December 2024 the North East CA were identified as one of eight Economic Inactivity Trailblazers, receiving £10m to bring together health, employment, and skills services to improve the support available to those who are inactive due to ill health and help them return to work. Removing barriers to employment is a key component of our ambition to make the North East the home of real opportunity and delivering the draft Local Growth Plan.
- 1.2 This £10M investment will provide us with the opportunity to develop and test new and innovative ways to address the persistent challenges of economic inactivity. Our aim for this activity is to harness untapped human potential to help grow our economy, raise living standards, reduce child poverty and create opportunities from which everyone can benefit. The Economic Inactivity Trailblazer investment will deliver three key objectives:
 - Maximise the reach, effectiveness and impact of the range of existing services that could support
 people who are economically inactive to participate in the labour market, by transforming how
 partners and services work together locally.
 - Test new and innovative approaches to identifying and engaging people who are economically inactive, and supporting people who are economically inactive to participate in the labour market by addressing gaps and responding to local needs; and
 - Provide a platform for longer-term systems reform, to deliver a coherent, joined-up local work, health and skills offer.

2. Our Approach and priorities

- 2.1 The Economic Inactivity Delivery Plan has been developed at pace and designed to accelerate delivery with a focus on achieving specific outcomes. We have created a mission-led approach, working across portfolios to align delivery to our strategic ambitions, including the Local Growth Plan, New Deal for NE Workers (employment and skills strategy) and Public Service Reform. Our proposal has been informed by robust evidence led labour market analysis, an evidence-base of activities we know work, engagement with our constituent local authorities and ensuring the principles of the programme aligned with the Single Assurance Framework (SAF).
- 2.2 The development of the Trailblazer Delivery Plan has been an iterative, fast-paced process, working closely with DWP colleagues at a national, regional and local level, with the final version signed off by the DWP Programme Board on the 10th April 2025. The following three priorities are the focus of investment and activity:
 - **Priority 1:** Better pathways into employment. Build upon local infrastructures, developing further an approach that seeks to provide an enabling environment and dedicated resources to bring together, coordinate and maximise the coherence and collective impact of existing and emerging employment support interventions.
 - **Priority 2:** New ways of working though market innovation. Invest in new provision, with the aim to stimulate market innovations that address recognised market challenges. By exploring models such as open innovation and challenge led innovation, we will invest in radical but practical solutions to the region's support ecosystem which provide learning and the opportunity for future scale-up.
 - **Priority 3:** Systems Reform integrated approach to health and employment. Establish radical and ambitious ways of working which break down barriers and reimagine processes in a way which creates best-in-class services for our residents across employment, skills and health. Through this work, we will seek to better understand different cultures and approaches in order to support integration and change that extends beyond short-term initiatives to long-term sustainability, with systems redesigned for lasting impact.

Collectively, the programme is expected to support over 1,350 economically inactive residents overcome health barriers and move closer to employment.

3. North East and North Cumbria Integrated Care System

- 3.1 Running alongside the development of the Trailblazer, the North East and North Cumbria Integrated Care System (NENC ICS) has been confirmed as a Health and Growth Accelerator and will receive just under £20M of funding in 2025/26 to deliver a programme of activity focused on improving population health outcomes and increasing economic growth by reducing health-related labour market inactivity. The principal objective of the Health and Growth Accelerator is to support 2,073 more people to be economically active through health-orientated interventions, compared to a donothing scenario, and take a new system-wide approach to learning and testing new ways of working at scale.
- 3.2 To ensure alignment of both the Health and Growth Accelerator and Trailblazer activity, a dedicated group has been established to oversee the development, implementation, and delivery of both programmes. The group comprises of representatives from NENC ICS, North East CA, DWP and Public Health.

4. Mobilisation and delivery

4.1 This investment has only been confirmed for the financial year 25/26, therefore the proposed approach to mobilisation and delivery is intended to allows us to operate at pace while embodying the programme principles of test and learn. It is proposed that most of the activity within the Delivery Plan is commissioned via an Open Calls process (Appendix 1). A phased approach has been used to administer the Open Calls, with the first two calls going live on 2nd June 2025. Specifications for each activity include the purpose of the call, alignment with the strategic context set out in the Combined

Authority vision and missions, rationale for the intervention, key objectives and primary benefits associated with the intervention.

- 4.2 Following the call process individual funding awards will be confirmed in line with the delegations set out in the Single Assurance Framework:
 - Less than £500k: via Delegated Decision Report
 - Between £500k to £1M: via TOG, then Delegated Decision Report
 - Over £1M: via TOG, Finance and Investment Board, then Delegated Decision Report
- 4.3 Some activity within the Delivery Plan will be established through a contract for service, including where there is need for a subject matter expert or capabilities to support system reform ambitions. Specifications for these services will be designed and administered in line with procurement regulations and brought forward again for approval under delegations set out in the Single Assurance Framework.
- 4.4 Financial allocations and intended outputs and outcomes for each activity within the three priorities are detailed within the Delivery Plan (Appendix 1).

B. Impact on North East Combined Authority Objectives

At the heart of the mayor's manifesto promises was an ambition to create opportunities for all, with an economy that works for the whole region and delivers sustainable growth. However, the North East faces a range of deep-rooted challenges including skills, productivity and GVA which fall behind national averages, poor indicators of health, including healthy life expectancy, and some of the highest levels of economic inactivity across the country. The Trailblazer offers us the opportunity to develop and test new and innovative ways to address the persistent challenge of economic inactivity – with the aim of harnessing untapped human potential to help grow our economy, raise living standards, reduce child poverty and create opportunities from which everyone can benefit.

C. Key risks

An integrated Economic Inactivity Trailblazer and Connect to Work Strategic Risk Register has been developed and is a standard agenda item at the joint Connect to Work and Economic Inactivity Trailblazer Implementation Group.

F. Equalities implications

The programme's commissioning approach has been designed to increase opportunities for residents most at risk of poor social and economic outcomes including women and girls, young people, social housing tenants. The programmes delivery model will be designed to support the North East CA's equality objective to work with partners and other funders to ensure our funding opportunities are accessible to organisations working with some of our most under-represented residents.

G. Consultation and engagement

Extensive consultation to support the design and development of this new programme has taken place with a range of key stakeholders including DWP, North East and North Cumbria ICB, members

of the North East Regional Labour Market Partnership (including VONNE and employer representatives), Mayoral Combined Authorities and the 7 constituent local authorities.
