A delegated decision, using the delegated authority given to the Head of Paid Service (in consultation with the Chief Finance Officer and Monitoring Officer) on 19th June 2018 (Minute 13), is sought to approve a payment of £72,630 which will be paid to Sunderland City Council by NECA as a condition of a 15-year lease between NECA and Sunderland City Council. The leased land will be the location of NECA's Electric Vehicle Filling Station as part of the Go Ultra Low North East project.

An original sum of £80,700 was sought by Sunderland City Council to reflect the loss of revenue from the current car park use of the site. After negotiations, this has been reduced to £72,630 to reflect the value of investment being made in Sunderland.
