Introduction of £1 21 and under fares on Metro, Shields Ferry and Secured Bus from May 2023

JTC Procedure Rule 33 - Urgent Decisions:
Where a decision needs to be taken urgently and it is not practical to convene a.quorate meeting of the appropriate body (i.e. the Joint Transport Committee, or any other committee, sub-committee of the Joint Transport Committee), the Head of Paid Service, in consultation with the Proper Officer for Transport, the Chair (or in their absence the Vice Chair) of the relevant committee, the Chief Finance Officer and the Monitoring Officer has the authority to take an urgent decision. In such circumstances, the Head of Paid Service must report that decision to the next meeting of the appropriate decision-making body which would have otherwise made that decision.
This decision needs to be taken urgently as Transport North East has set a date of 7 May 2023 to launch the £1 offer across all buses in the region. In order to align with this and ensure a simple message for customers across the region, Nexus would like to implement the £1 offer on Metro, Shields Ferry and buses within our control from the same date.

The Junior Blue smartcard which is aimed at those aged 16 and under will continue to be offered, owing to the lower price point offered for a day's travel.

The changes proposed on Metro will be mirrored on Shields Ferry and the limited number of bus services (secured bus services) where Nexus takes the revenue risk and sets fares.

By ensuring services under Nexus' control are brought into alignment with the improvements bus services will see as a result of the BSIP, Nexus is ensuring that the overall public transport offering is as attractive as possible to young people, helping to ensure a more sustainable future for the region.

The TWSC Members present at the meeting on 6 April 2023 were supportive of the proposals contained in the attached report.
