The North East Joint Transport Committee in December 2022, were awarded £1,413,507 from Active Travel England, for the 2022-23 Capability Fund. £20,000

of this was awarded to develop and deliver bespoke active travel training for Local

Authority officers and members. The North East Joint Transport Committee noted the purposes of this funding in the JTC revenue budget for 2022/23 and 2023/24. The procurement of professional services has been undertaken, with the aim of enhancing knowledge and advocacy, particularly in decision making, policy and design. There will be two workstreams to this training, with one workstream aimed at decision makers, e.g. planning committee and transport committee members, and the other workstream aimed at officers, e.g. in design, highways, transport and planning teams.
