### 1. Purpose

1.1 The overarching objective of this commission will be to: produce a programme level Business Case for the Bus Service Improvement Plan (BSIP) funded Safe and Accessible Bus Stations work stream.

The Taks associated with the production of the Business Case include:

- Conduction inception and regular engagement sessions with scheme promoters
- Complete all aspects of the WebTAG compliant 5 case Business Case
- Ensure a programme of schemes can be delivered by March 2025
- Undertake VfM and BCR calculations
- Undertake a full QRA
- Provide support to local authorities and assist in all assurance undertakings

A procurement process has been carried out on behalf of Transport North East by Durham County Council using their procurement contractor Bloom. The procurement was carried out via a competition and nine potential suppliers were invited to bid.

Following tender evaluation and moderation this report seeks approval to award the contract to Jacobs who will provide the required professional services to produce a Programme Level Business Case for the BSIP Safe and Accessible Bus Stations workstream in order to ensure delivery within the required BSIP programme timeframe in which all schemes must be contractually committed by March 2025.

#### 2. Recommendations

2.1 To grant approval to appoint Jacobs to lead on the aforementioned commission, the value of the contract is £74,334.

### 3. Background

- 3.1 At the December 2023 meeting of the Joint Transport Committee, Members delegated authority to the Managing Director, Transport North East, following consultation with the Monitoring Officer and Chief Finance Officer, to procure professional services and support as required up to the value of £350,000 to advance BSIP capital sub-programmes. The Safe and Accessible Bus Stations is the first workstream to come forward drawing down on this budget.
- 3.2 A full procurement exercise has been carried out in order to procure a supplier who will provide professional services to produce the required Programme Level Business Case

to ensure delivery within the required programme timeframe in which all schemes must be contractually committed by March 2025.

3.3 The specification was sent to nine potential suppliers via Bloom. The tender returns were reviewed on a 70% quality and 30% price basis. The tender price of the successful supplier (£74,334) falls within the identified available budget of £100,000 and offers excellent value for money.

### 4. Considerations

Bloom's Procurement Team has carried out this procurement exercise in line with the terms and conditions of their procurement contract with Durham County Council. There are no further considerations to consider.

#### 5. Consultation

5.1 Officers from Transport North East were involved in the development of both the tender specification and assessing the tender responses.

## 6. What happens next

6.1 With the approval of the Managing Director, Transport North East, Jacobs will be notified of our intention to award the contract and enter into the agreement. A contract will then be prepared and sent to them for signature.
