#### 4. MINUTES OF THE INQUORATE MEETING HELD ON 19 DECEMBER 2019

Apologies received from ClIr A Batey were added to the minutes. The minutes were approved as a correct record.

#### 5. COVID-19 REGIONAL ECONOMIC RECOVERY

Submitted: Report of the Chief Executive, Sunderland City Council (previously circulated and copy attached to the official minutes).

Catherine Auld, Assistant Director of Economic Regeneration at Sunderland City Council presented the report and delivered a presentation. The presentation outlined the Regional Recovery from Covid-19 and covered the following topics:

- Local Impact of Covid-19
- Regional Structure and Four Workstreams
- Government Interventions
- Local Restrictions on LA7
- Economic Recovery and Asks of Government

The following points were highlighted during the presentation:

- Vast majority of businesses and sectors impacted locally by Covid-19, with a large reduction in footfall in town centres;
- Disproportionate impact on the most vulnerable and disadvantaged;
- Regional Response and Recovery groups are now working concurrently, with the Response Groups recently being stood back up;
- Looking ahead, significant challenges remain and updates on the Comprehensive Spending Review, Local Recovery and Devolution White Paper and UK Shared Prosperity Fund will continue to be monitored;
- The region has pulled together to create a Covid-19 Economic Response Group, with the North East Recovery and Renewal Deal focussing on a transition to a cleaner, greener and more inclusive economy;
- The five key areas of the emerging recovery package include: Job Recovery, Building the Economy of the Future, Supporting Businesses, Community and Place and a Connected North East.

During discussion, the following points were discussed by Members:

- There is still much uncertainty underlying the current situation. For example, there is no clarity regarding the replacement of EU Structural Funds. Without all the tools available there is a risk of losing jobs;
- Good communication with local businesses and communities in the short and long-term is very important;
- Much guidance is still required regarding possible funding streams available;
- The hospitality and leisure sectors are amongst the hardest hit due to Covid-19. Smaller and independent venues are struggling and cannot compete with larger chains and corporations. The hospitality sector is at the heart of our town centres and the balance needs to be redressed to support them;
- An online sales tax may be a possible way to help support our city centres and high streets. This could be investigated further by NECA's Economic Development and Digital Advisory Board;
- The Kickstart Placement scheme will not be useful without footfall in town centres;

- Further information is required in regards risks that the local area and sectors face during the recovery;
- The issue of who exactly owns shopping centres in terms of rates and rents is important. Better relations are needed as sometimes people may choose not to invest in a shopping centre due to owners or landlords taking unnecessary amounts of time during discussions or not providing all the required information;
- The NELEP is producing regular Economic Intelligence Reports, which may be of interest to the Committee.

C Auld was thanked for the informative presentation and discussion.

#### AGREED – That:

- i. the report and presentation be noted;
- ii. the issue of an online sales tax be further investigated;
- iii. a special meeting of the Committee be arranged to investigate the impact of Covid-19 on town centres, with information requested from the NELEP.

#### **Executive Summary**

This report provides the Overview and Scrutiny Committee with an update on the NECA Budget Proposals for 2021/22 and future years as part of the budget consultation process.

A report on the draft 2021/22 Budget was presented to the Leadership Board on 3 November 2020. That report is attached as an appendix for consideration and comment. Included in the report is an updated forecast of outturn for the current year against the budget agreed in January 2020.

The views of the Overview and Scrutiny Committee will be considered in the development of the final budget report and reported to the NECA Leadership Board when it sets the budgets for 2021/22 at its meeting in February 2021.

#### Recommendations

The Overview and Scrutiny Committee is recommended to receive the report for information and provide comment for consideration as part of the consultation process.

#### 1. Background Information

1.1 The purpose of this report is to seek the views of the Overview and Scrutiny Committee on the proposals for the 2021/22 NECA budget, as part of the consultation process. The report on the draft budget was presented to the Leadership Board on 3 November and is attached to this report.

#### 2 Proposals

- 2.1 The draft budget proposals for 2021/22 set out in the report attached at Appendix 1.
- 2.2 Key proposals presented to the NECA Leadership Board on 3 November include:
  - a) The contribution from the NECA constituent authorities to NECA corporate costs be set at £25,000 per authority next year (currently £22,857 per authority). This is the first time that an increase has been requested since the establishment of NECA in 2014 as is required to meet staff costs which have been increasing over time through pay awards and incremental progression, and Service Level Agreements (SLAs) which are also largely driven by staff costs. The SLAs underpinning NECA and the Joint Transport Committee (JTC) have all been subject to review by the relevant lead authorities during the last six months; and
  - b) The £70,000 contribution towards the costs of the JTC Accountable Body role is continued in 2021/22 through an equal contribution of £10,000 from the seven local authority members of the JTC though there will be a need to review these contributions in 2022/23.

#### 3. Reasons for the Proposals

3.1 As part of the process for setting its budget, NECA must ensure appropriate and effective consultation takes place with all Members and other stakeholders on the content of the Budget. This includes consultation with the Overview and Scrutiny Committee and this report provides an opportunity for such consultation to take place.

4.1 The report is presented for information.

5.1 Comments made as part of the consultation process will be considered in the development of the final, detailed budget proposals for 2021/22 which will be presented to the NECA Leadership Board for approval in February 2021.

#### **Executive Summary**

This report sets out high level budget proposals for 2021/22 for the NECA Corporate Budget including fulfilment of its Accountable Body role for the North East Joint Transport Committee.

The report highlights that the initial budget estimates for 2021/22 are in line with the forecasts set out as part of the Medium-Term Financial Strategy (MTFS) presented to the Leadership Board in February 2020.

It is anticipated that, as set out in February 2020, NECA Corporate contributions will increase to £25,000 per authority next year (currently £22,857 per authority). This is the first time that an increase has been requested since the establishment of NECA in 2014 and is required to meet staff costs which have been increasing over time through inflationary pay awards and incremental progression, and Service Level Agreements (SLAs) which are also largely driven by staff costs. The Service Level Agreements underpinning NECA and the Joint Transport Committee have all been subject to review by the relevant lead authorities during the last six months.

It is anticipated that contributions to the Joint Transport Committee (JTC) Accountable Body role can be maintained at the current level of £10,000 per authority in 2021/22, though there will be a need to review these contributions in 2022/23.

The budget proposals will be subject to further discussion and consultation and a report presented to the next meeting of the Leadership Board.

#### Recommendations

The Leadership Board is recommended to receive the report for information and comment.

#### 1. Background Information

- 1.1 A report was presented to the Leadership Board in July setting out the proposed budget setting timetable for 2021/22.
- 1.2 This report sets out initial budget proposals for the NECA Corporate budget and the Joint Transport Committee (JTC) Accountable Body budget.

#### 2. Proposals

#### NECA Corporate Costs

- 2.1 The NECA budget for corporate costs is required to support operational costs including staffing employed by NECA, Service Level Agreements (SLAs), independent members allowances and expenses and supplies and services costs.
- 2.2 The report to the Leadership Board on 4 February 2020 set a net NECA Corporate budget for 2020/21 of £192,780, which provided for NECA corporate capacity and to fulfil the JTC Accountable Body role. This is funded from contributions from NECA constituent authorities totalling £91,428 (£22,857 per authority), contributions from JTC constituent authorities totalling £70,000 (£10,000 per authority) and interest income on short term investments.
- 2.3 A forecast outturn for 2020/21 was presented to the Leadership Board in July 2020. The forecast for income includes additional investment income which is expected to be received due to higher cash and short-term investments balances being held at the beginning of the financial year. This allows a small contingency to be available in the NECA corporate budget to meet any costs that may not have been anticipated at the time of setting the budget.
- 2.4 The expenditure forecast includes grant funded activity. As previously reported to the Leadership Board, NECA allocated £95,000 of grant funding received from MHCLG to support the North East Brexit Work Programme, including Trade Facilitation and Free Zone work and a joint coordinating post with the North East LEP and the North of Tyne Combined Authority. £34,000 of the amount allocated was claimed by the LEP at the end of the financial. The remaining £61,000 is included in the updated forecasts for 2020/21 and is expected to be drawn down to support expenditure this year.
- 2.5 The budget agreed in February 2020 also set out initial proposals for years 2 and 3 of the Medium Term Financial Plan for NECA, which included a small increase in contributions to keep pace with increases in staff costs due to pay awards, and Service Level Agreements (which are also largely driven by staff costs).

- 2.6 For 2021/22, an initial budget of £201,520 is proposed, to be met from NECA corporate contributions totalling £100,000 (£25,000 per authority representing an increase of £2,143 per authority) and JTC Accountable Body contributions totalling £70,000, plus interest income on short term investments. This is the first time that an increase has been requested for the NECA corporate contributions since the establishment of NECA in 2014.
- 2.7 Appendix 1 sets out the proposed budget for 2021/22 along with an initial estimate for 2022/23 and the updated forecast for 2020/21.

#### **SLA Review**

- 2.8 For 2020/21 all SLAs were documented and formalised however the values attached to existing and new providers of services were maintained at 2019/20 levels and which had remained unchanged for many years. It was agreed that an exercise would be undertaken to review the SLAs to more accurately reflect the support to NECA and the JTC.
- 2.9 An exercise has now been concluded with all local authorities providing services to NECA and the JTC to reflect the cost of these services for 2021/22. Costings have been based on officer time engaged in providing support with no provision for additional on-costs such as premises related costs.
- 2.9 The additional costs associated with the NECA corporate and JTC accountable body role will be accommodated from the planned increase in the NECA corporate contributions from the four constituent authorities (an increase from £22,857 per authority to £25,000 per authority). The contributions to the JTC are proposed to remain in line with the existing contribution levels (£10,000 per authority) in 2021/22. This position will be reviewed in 2022/23.

#### 3. Reasons for the Proposals

- 3.1 This report sets out the initial high-level budget proposals for 2021/22 for the NECA Corporate budget, including fulfilment of its Accountable Body role for the North East Joint Transport Committee.
- 3.2 The report identifies that, as set out in February 2020, NECA Corporate contributions need to increase to £25,000 per authority next year (currently £21,430 per authority). Contributions to the Joint Transport Committee (JTC) Accountable Body can be maintained at the current level of £10,000 per authority in 2021/22 and will be reviewed for 2022/23.

#### 4. Alternative Options Available

- 4.1 The increase in the corporate contributions are required to reflect the outcome of the review of Service Level Agreements that underpin and support NECA and the JTC.
- 4.2 The report is presented for information with no decision required at this stage the information set out will be included in the 2021/22 NECA budget setting report which his agreed in February 2022.
- 4.3 In considering the content of this report the Leadership Board may:
  - (a) Note and accept the budget forecasts, which seek to set a balanced budget that accurately reflects the costs of providing the support to NECA and the JTC.
  - (b) Retain the existing budget provisions for corporate contributions and SLAs which do not reflect the resources currently committed by the local authorities providing the support to NECA.

#### 5. Next Steps and Timetable for Implementation

5.1 The NECA Constitution requires that consultation on budget proposals be undertaken at least two months prior to the budget being agreed. The draft proposals will be subject to consultation with the Leadership Board, Overview and Scrutiny Committee, Audit and Standards Committee and officer groups. In its Accountable Body role for the JTC, Transport proposals will also be subject to consultation with the JTC Overview and Scrutiny Committee, JTC Audit Committee, the JTC Tyne and Wear Sub Committee and constituent councils. Comments raised as part of the consultation process will be taken into account in the preparation of the final reports.

#### 6. Potential Impact on Objectives

6.1 The budget and medium-term financial strategy will be prepared to reflect the objectives of the Authority. Future reports will set out the revenue and capital budget proposals in more detail that will help deliver the objectives of the Authority.

#### 7. Financial and Other Resources Implications

8.1 The budget must be approved unanimously in accordance with the requirements of the NECA Order and the NECA Constitution.

# 1. Economic impact

- Main impact will be on trade so likely to be felt by exporters (60% of NE exports to EU), importers and complex supply chains
- Manufacturing and automotive could see 10% tariffs (Nissan say UK operation 'unsustainable,' Prima Cheese concerns on tariffs)
- Non-tariff barriers will lead to rising costs, delays and bureaucracy
- Impact will be felt regardless of deal (but more severe if no deal)
- Could lead to rise in food costs as well as skills challenges
- Evidence of NE firms putting investment plans on ice and seeing reduced orders (ONS say 30% of exporters doing less than normal)
- Larger firms better prepared than SMEs given depleted cashflows
- Business investment taken hammering from CV19 and likely to be punctured further by EU Exit costs
- Local Authority business support teams raising awareness amongst SMEs and signposting towards regional support and Gov advice



# 2. Labour market impact

- End of free movement with new points-based immigration system coming in 1<sup>st</sup> Jan
- Aim to attract "scientists, academics and highly-skilled", ending lowskilled or temporary worker routes
- Migrants need to meet 70 points; 20 for shortage occupation, 20 for salary above £25.6k; 10 for PhD (focus on Level 3)
- Impact differs by sector; IPPR say biggest on health and social care, hospitality, construction, transport and logistics
- 23% of NE employers are worried about skills gaps post Brexit
- Given small proportion of NECA residents from outside UK (28k / 2.4%), new rules may not directly impact
- However, changes may impact upon businesses ability to fill skills gaps (particularly in NHS) or deter international students
- Yet, opportunity to reskill and upskill our residents to plug vacancies



# 3. UK Shared Prosperity Fund

- European Structural & Investment Funds (ESIF) end on 31<sup>st</sup> Dec
- Programme and spend can continue until June 2023, but question marks over underspend
- ERDF and ESF have been vital funding sources for capital programmes, business support and skills and employment schemes (£437m 2013-2020)
- 2020 Spending Review said UKSPF would reach £1.5bn a year
- UKSPF not available until 2022 (£220m to prepare in 21/22)
- UKSPF will target "ex-industrial areas, deprived towns and rural and coastal communities"
- Questions over funding, match, eligibility, outputs, flexibility, timelines, geography and fit with other devolved funds (ie LGF)
- Spending Review also suggested highly centralised model
- Further detail published in the Spring



# 4. Impact on NECA

- Main short-term impacts will come via product delays, regulatory and funding stream changes and sense of uncertainty
- Potential large impact across constituent Council services, including on business support, capital funding, procurement, adult social care and welfare support
- Longer-term economic impact likely to depress growth (according to OBR, Bank of England and Treasury)
- Impact will effect NECA Economic Plan, investment plans and ambitions
- Concerns around UKSPF ability to fund key projects or provide joined-up devolved funding to drive growth
- However, opportunities to bring manufacturing supply chains back to the UK, use a North East Free Zone to drive export-led growth and access flexible future funding (UKSPF)



# 5. Next Steps

- Local Authorities ramping up business comms (signposting to North East Growth Hub, NECC and Gov advice)
- Liaising with key employers, strategic assets and business groups
- Continue to work with partners on NE Freeports bid and need for devolved, flexible UKSPF
- Work with Invest NE on FDI and Internationalisation Strategy
- Ensure NECA Economic Plan reflects new reality post EU Exit and CV19 given their twin impact on its key themes

3.1 Covid-19 has created the biggest economic shock of our lifetimes and its impacts, both in the immediate and longer term, will be complex and significant. The presentation will update the Committee on the economic recovery work undertaken to date, to support a discussion on the key challenges and opportunities for the NECA area.

#### **Executive Summary**

The purpose of this report is to provide Members of the Overview and Scrutiny Committee with an opportunity to consider the items on the Forward Plan for the current 28-day period and discuss items for the Work Programme for 2020 / 2021.

#### Recommendations

The Overview and Scrutiny Committee is recommended to:

- i. Review the current Forward Plan and consider which items they may wish to examine in more detail;
- ii. Suggest any items for the Work Programme for 2020/2021 that Members would wish to explore in more detail, either at the Committee or via a 'deep dive' or working group;



#### 1. Background Information

- 1.1 The Forward Plan is a document which NECA is required to maintain under the Combined Authorities (Overview and Scrutiny, Access to Information and Audit Committees) Order 2017. The Forward Plan is published on NECA's website and lists the decisions that the North East Combined Authority intends to take in the coming months and must include all decisions to be made in the next 28 days.
- 1.2 The Forward Plan template contains specific information relating to each decision, including the date the decision will be made, a brief explanation of the topic, the consultation to be undertaken, and contact details of the author. The Forward Plan template has recently been updated and includes further information including if the decision is a 'Key Decision' and if an item will be discussed in private.
- 1.3 Details of each decision are included on the Forward Plan 28 days before the report is considered and any decision is taken. This supports the transparency of decision making within the Combined Authority and allows members of the public to see the items that will be discussed. There are special procedures for circumstances where publication for the full 28 clear day period is impractical or where there is special urgency. Both of these procedures involve the Chair of the Overview and Scrutiny Committee and would be reported to the Overview and Scrutiny Committee at its next meeting.

#### **Role of Overview and Scrutiny**

- 1.4 The Overview and Scrutiny Committee examine any decisions of the North East Combined Authority – be that by the principal decision-making body or a committee or officer holding delegated authority. This Scrutiny occurs in public and ensures democratic and public accountability.
- 1.5 One of the main functions of the Overview and Scrutiny Committee is the review and scrutiny of 'Key Decisions' made by the NECA Leadership Board and Officers of the Combined Authority. The relevant regulations set out a test for what should be considered a Key Decision being those which are most significant in financial or other terms. This is explained in the Decision-Making Protocol adopted by the Committee on the 15 March 2018. At the inaugural meeting of the NECA Leadership Board on the 13 November, following the governance changes, it was agreed that the Decision Making Protocol would remain in place:

- 1.6 It is NECA's practice to include formal decisions on the Forward Plan to maximise the opportunity for review and scrutiny. In considering items in the Forward Plan, the Overview and Scrutiny Committee should determine which areas scrutiny can add most value to in relation to the decisions being made.
- 1.7 The Forward Plan at the date this paper was issued is attached marked as Appendix1. The up to date forward plan is always published at

1.9 The table above reflects that there have been no requests for general exception and no requests for special urgency since the last Committee.

#### Annual Work Programme - Update

- 1.10 The most recent version of the work programme has been compiled to allow the Overview and Scrutiny Committee the opportunity to consider items that they have requested.
- 1.11 The work programme is also designed to give an overview of all performance, decision-taking and developments within the NECA, as well as being focused and flexible to allow for new issues and recognising the capacity of the scrutiny committee to respond in a timely way to emerging developments throughout the year. The Plan allows the Committee to take a longer-term view than the Forward Plan, adding a longer term perspective to the Committee's work. Advantages of a longer-term perspective is the opportunity to gain a deeper understanding of matters and to allow for more constructive engagement and scrutiny.

- A joint informal briefing with the North of Tyne Overview and Scrutiny committee was

- 1.14 The OSC meet informally with representatives from the North East Local Enterprise Partnership (NE LEP) to discuss the effects of COVID 19, and associated restrictions, on businesses across the region and in particular those in high streets. The committee agreed to continue to keep a watch on the issue.
- 1.15 The proposed work programme included in appendix 2. It should be noted that the work programme covers items that will be discussed at the meetings. It does not preclude 'deeper dives' providing more focused scrutiny of particular topics by a sub-group of the committee outside of these meeting dates. These topics can be raised with the Chair and Scrutiny Officer at any time.
